

# 2010 Reisterstown Festival Rules and Regulations

## (Lease Addendum)

1. **Exhibitors/Vendors will furnish all tables, chairs, and equipment relevant to their display. The Festival Committee will not provide anything except the 14' by 10' space. (food vendors, 18'X10' space)** Tables MUST be covered to the ground to ensure a neat and uniform appearance. Stock boxes must be stored under tables, out of the way of the public and adjacent operators. Trash receptacles will be provided throughout the festival grounds. Each space must be left clean at the end of each day.
2. **No construction** of any kind may be done by exhibitors/vendors on site at the Festival. All stands and displays must be of a prefabricated and easily erected nature.
3. **Canopies** are allowed and recommended, however, each must be in good condition, attractive in appearance and free standing with weights and/or bricks. **Almost all booths are on the blacktop this year, so staking into the ground will not be possible.**
4. **No** merchandise or advertising materials may be suspended from or attached in any of the trees on the grounds. **No** advertising signs may be posted on the grounds.
5. Any items deemed of a "Flea Market" nature by the Committee must be removed from the Exhibitor's display.
6. All prices must be clearly marked and **non-negotiable**. No "Hawking" of wares by vendors will be permitted.
7. Exhibitors/Vendors will be responsible for the conduct of their children and members of their party.
8. **NO ALCOHOLIC BEVERAGES ARE PERMITTED ON THE FESTIVAL GROUNDS, OTHER THAN IN THE DESIGNATED INTERNATIONAL GARDEN.**
9. **Each exhibitor/vendor is responsible for obtaining their own appropriate permits and licenses.**
10. All exhibitors/vendors required to pay Maryland State Sales Tax must do so on an individual basis. FOR SPECIFIC INFORMATION CONTACT:

11. Exhibitors/vendors assume liability for accidents, which occur as a result of negligence on their part.
12. Festival will be held rain or shine; **no refunds will be made due to weather conditions.**
13. **Location of each booth** is at the discretion of the Festival Committee depending on availability and safety for the vendor and attendees.
14. If you want a vehicle in your booth, it must be Ok'd ahead of time.
15. There is overnight patrolling security. You do not have to break down your booth Saturday evening.
